## Recommended and Unconditional Takeover Offer for Bullseye Extended

Emerald Resources NL (ASX: EMR) ("**Emerald**" or "**Company**") refers to its previous announcements in relation to the recommended and unconditional takeover bid for all of the issued shares of Bullseye Mining Limited (**Bullseye**) that it does not already own (**Offer**).

The Offer is unconditional and remains open for acceptance, as such Emerald encourages all Bullseye shareholders who are yet to accept the Offer made to them to do so and reminds them they will be issued with their Emerald shares within 10 business days of their acceptance being processed in accordance with the terms of the Offer. Emerald notes that any Bullseye shareholder who accepts the Offer and disposes of any of the Emerald shares issued to them as consideration, is deemed to have forfeited their withdrawal rights.

Emerald has today resolved to extend the closing date of the Offer to **5.00pm (AWST) on Friday 5 April 2024** (subject to further extensions to be made by Emerald to ensure the Offer remains open until 5:00pm (AWST) on the date that is 10 business days after the date of Bullseye's Supplementary Target's Statement).

Emerald refers to today's update from Bullseye in relation to the timing of the release of the Supplementary Target's Statement (which includes the independent expert's report) (refer [www.bullseyemining.com.au](http://www.bullseyemining.com.au)) which is expected no later than 5 April 2024. Further details regarding the effect of the Takeovers Panel Orders are set out in the Company's announcement dated 9 October 2023.
